

PrescQIPP 2020/21 work plan released

We are pleased to announce the release of the PrescQIPP primary care work plan for 2020/21

The work plan will be put in the "What's coming up next" section of our website in due course where you will be able to track the progress of each bulletin.

The workplan has been put together and voted on by the subscriber membership after a consultation period which started at the annual event 2019. Bulletin launch dates have been aligned with predicted drug launches where known.

One slot has been incorporated for national work, we will review this if needed. Workplan items have been removed where RMOCs, NICE or other organisations have since announced they will be producing resources.

Proportion of workplan allocated to different types of resource

We have divided the work as near as possible as voted for by our subscribers actual % (voted %):

Skills & competencies - 21% (21%)

QIPP/Savings - 38% (34%)

Clinical/ therapeutic - 24% (29%)

Non-clinical MO - 17 % (15%)
