

## Access to PrescQIPP e-learning courses

 <p><b>Anticholinergic burden</b></p> <p>This course is designed for MMTs, GPs, practice nurses, practice pharmacists, PCN pharmacists and non-medical prescribers. It identifies how the anticholinergic burden can be assessed for individual patients and provides examples of medication reviews for those with a high burden.</p>	£14.99
 <p><b>Anticoagulation</b></p> <p>This course is designed for MMTs, GPs, practice nurses, practice pharmacists and non-medical prescribers. It is based on the NICE CG 180: Management of Atrial Fibrillation. It covers the appropriate use of anticoagulants in AF, including assessment of stroke and bleeding risks, choice of agent, monitoring, adverse effects and interactions.</p>	£12.50

 <p>Chronic heart failure in adults</p>	<p><b>Chronic heart failure in adults (endorsed by NICE)</b></p> <p>This course is designed for MMTs, GPs practice nurses, practice pharmacists and non-medical prescribers. It is based on NICE guideline 106 and covers the diagnosis and pharmacological management of chronic heart failure. It also covers lifestyle factors, although management of acute heart failure, interventional procedures and palliative care are beyond the scope of the course.</p>	<p><b>£14.99</b></p>
 <p>Dependence Forming Medications</p>	<p><b>Dependence Forming Medications</b></p> <p>This course is designed for MMTs, GPs, practice nurses, practice pharmacists and non-medical prescribers. The modules cover the statistics around the use of DFMs, opioids, benzodiazepines &amp; z-drugs and gabapentin &amp; pregabalin. It offers practical advice regarding the initiation of these medicines and how long-term use can be reviewed and managed. Case studies and advice from two GPs with a special interest in this area support the learning.</p>	<p><b>£14.99</b></p>
 <p>Medicines use in care homes Course 1</p>	<p><b>Medicines use in care homes 1 (endorsed by NICE)</b></p> <p>For care homes staff and covering the role of CQC and the NICE Guideline and Quality Standards, the management of medicines in care homes and self-medicating residents. It also has modules on the administration of inhalers; eye drops; transdermal patches; topical creams and as required medicines. PrescQIPP is a Skills for Care Endorsed Provider.</p>	<p><b>£14.99</b></p> 
 <p>Medicines use in care homes Course 2</p>	<p><b>Medicines use in care homes 2 (endorsed by NICE)</b></p> <p>This is the second e-learning package to support care home staff involved in any aspect of medicines use and covers: refused and omitted doses; covert administration; controlled drugs; bulk prescribing; homely remedies; and waste medicines reduction. PrescQIPP is a Skills for Care Endorsed Provider.</p>	<p><b>£14.99</b></p> 
 <p>Medicines use in care homes Course 3</p>	<p><b>Medicines use in care homes 3</b></p> <p>This course aims to support care home staff involved in any aspect of medicines use and covers the use of certain 'high risk' or specialist medicines that require specific consideration and/or administration techniques.  <p><b>Optimising medicines for adults with type 2 diabetes (endorsed by NICE)</b></p> <p>This course updates practitioners on the content of the NICE management of type 2 diabetes in adults guidelines, and illustrates how the principles of medicines optimisation can be used to improve patient care, safety and outcomes.</p>	<p>£12.50</p>
 <p><b>Practice medicines co-ordinators</b></p> <p>This course is designed for non-clinical staff in GP practices who manage the repeat prescribing process. It covers; medication basics, information sources and requirements for prescriptions; repeat prescribing; care home and appliance contractors; hospital discharge, formularies, specials and prescribing incentive schemes; community pharmacy services; diabetes, respiratory prescribing and antibiotics.</p>	<p>£12.50</p>
 <p><b>Polypharmacy and deprescribing - Full course</b></p> <p>A full length course designed for non-medical prescribers and trainee GPs. It covers the concepts of polypharmacy and deprescribing, describes when polypharmacy may be appropriate or inappropriate and how this occurs. It provides practical advice on the initiation of medicines including shared decision-making with patients.</p>	<p>£12.50</p>
 <p><b>Polypharmacy and deprescribing - Concise course</b></p> <p>A concise version designed for GPs and more experienced healthcare professionals with some knowledge of the issues. The course includes modules on the background to deprescribing; multimorbidity; frailty; shared decision making and medication review and includes four case studies.</p>	<p>£12.50</p>
 <p><b>Reducing opioid prescribing in chronic pain</b></p> <p>This e-learning course is designed for medicines management teams, GPs, practice nurses, practice pharmacists and non-medical prescribers. The course will help equip healthcare professionals to tackle the growth in opioid prescribing and improve care for patients with chronic pain.</p>	<p>£14.99</p>
